OPTION 3: **Assisted Self-Prep (D-I-Y)**

Start on your tax return today!
We help you prepare your return over the phone.

Go at your own pace with simple IRS-recommended click-through software. We'll help if you get stuck!

- You can call us with your questions; we'll help you every step of the way!

Documents You'll Need:

- Government-issued photo ID (passport, driver's license, etc.)
- Social Security card(s) from the Social Security Administration, or ITIN letter(s) for yourself & all individuals on your return
- All wage statements (W-2 forms, 1099-R [if you received income from your retirement plan], 1099-G [if you received Unemployment Insurance], etc.)
- Documentation of higher education expenses, including tuition paid, loans received, student loan interest payments & student fees
- Child-care expenses, including provider information & tax ID number
- IRS IP PIN if you were assigned one due to tax-related identity theft
- Bank account number and routing (ABA) number for direct deposit

Eligibility:

- With dependents? Income of \$68,000 or less,
- Single? Income of \$48,000 or less,
- Self-employed? Anyone with expenses of \$5,000 or less.
